Facility made the work order (#10091044). At time of inspection it observed kitchen have in total six handwashing sinks including bathroom. CODE REFERENCE: 64E-11.003(3). Employees must use proper handwashing techniques and wash hands at appropriate times and places.</p>
<p>Violation #54. Garbage &amp; refuse disposal Replace a rusty broken container for garbage. At time of inspection it observed a leak at the bottom. Green Dumpster is located next to the blue container. CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.</p>
